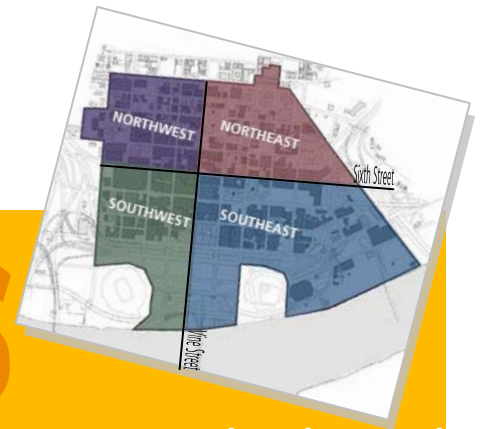

Sector Groups

Downtown Cincinnati



A sector group is a group of interested downtown stakeholders including property owners, retailers/merchants, residents, etc. in a particular geographical boundary of downtown. Monthly and bi-monthly meetings are held and attended by Cincinnati Police Downtown Services Unit (DSU) and Downtown Cincinnati Inc. (DCI) representation. The purpose of these meetings is to identify, discuss and resolve environmental (safe and clean) issues within the particular sector as well as provide an opportunity for those in the sectors to get to know and work with one another.

The Downtown Sectors are within the Special Improvement District which DCI serves. The boundaries are Eggleston Avenue on the east, Central Parkway on the north, Central Avenue on the west (including the Centennial Buildings), and the Ohio River on the south (excluding the stadiums).

Although DCI helps to facilitate the groups and assist with problem solving, the sectors are led by stakeholders within the respective sectors. The sector leaders coordinate the meetings, the agendas and minutes, and maintain a member database. The leaders from all sectors meet monthly to review issues in their particular sector as well as share progress reports, develop strategies to solve problems, and identify positive stories that may be of interest to the media.

The NORTHEAST Sector is within the boundaries of the south side of Central Parkway, the east side of Vine Street, the north side of Sixth Street and Eggleston Avenue.

The NORTHWEST Sector is within the boundaries of the south side of Central Parkway, the west side of Vine Street, the north side of Sixth Street and Central Avenue.

The SOUTHEAST Sector is within the boundaries of the south side of Sixth Street, the east side of Vine Street, the Ohio River and Eggleston Avenue.

The SOUTHWEST Sector is within the boundaries of the south side of Sixth Street, the west side of Vine Street, the Ohio River and Central Avenue.
